## SPONSORSHIP TERMS & CONDITIONS

### Sponsorship Fees and Payment Terms

The Sponsor acknowledges and agrees that the Sponsorship Agreement is a binding contract once it is signed by the Sponsor.

If the Sponsorship Agreement is concluded, the organizer will invoice the Sponsor for the full amount of the Sponsorship Fee and the payment shall be made in one instalment of 100% of the Sponsorship Fees.

### Cancellation by Sponsor

If the Sponsor cancels the Sponsorship on or before 01. July 2026 a Cancellation Charge of 50% of the Sponsorship Fee will apply.

If a Sponsor cancels the Sponsorship after 01. July 2026, the Sponsor agrees to pay 100% of the contracted Sponsorship Fee as Cancellation Charge. If a Sponsor cancels with an outstanding balance due, the Sponsor remains responsible for the entire balance due, plus reasonable legal fees to collect.

Cancellations must be received in writing by the non-profit association.

Upon receipt of Sponsorship cancellation notice, the organizer shall have the absolute discretion to resell the sponsorship item(s) forfeited.

The Sponsor hereby acknowledges that the cancellation charge represents a reasonable pre-estimate of the likely losses and costs that would be incurred by the organizer as a result of the Sponsor's cancellation and that they do not represent a penalty. For the avoidance of doubt, the organizer is not required to mitigate its losses and/or costs in such circumstances and the cancellation charge shall remain payable even where the organizer is able to resell the sponsorship item.

If the event can only take place online or not due to force majeure (e.g. pandemic), official orders for which the organizer is not responsible or other reasons for which the organizer is not responsible, or if the implementation has become unreasonable, a cancellation charge of 50% of the Sponsorship Fee will apply.
