Your personal data are processed in accordance with Regulation (EU) 2018/1725¹ on the protection of individuals with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

The data controller of the processing operation is the Head of Unit C2 Administration of the Executive Agency for Small and Medium-sized Enterprises (EASME).

The recipients of your data will be relevant EASME and European Commission staff in charge of the organisation of the event and, EASME's contractor NEEMO EEIG — AEIDL (and its subcontractors) involved in the organisation of the event and the follow-up communication activities, and bodies charged with monitoring or inspection tasks in application of EU law (e.g. internal audits, Court of Auditors, European Anti-fraud Office — OLAF), as well as participants of EUSEW.

Your personal data **will not be transferred** to third countries or international organisations. The processing of your data will **not include automated decision-making** (such as profiling).

If processing is based on your consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of the processing based on your consent before its withdrawal.
