Expression of Interest

This Expression of Interest (EOI) is the first step in the process to submit a Canadian Collaboration Program Project Proposal. This document will be used to verify that both consortium and project idea meet the eligibility requirements of the program.

Applications will be ranked on both eligibility and merit, and only applicants ranked above a certain threshold will be invited to submit a full project proposal. NRC may choose to rescind an invitation to the full project proposal stage if it is discovered that the applicant does not meet the eligibility requirements of the call.

How to Submit

- Once the form is complete, save the PDF locally adding the acronym the consortium has chose for the project to the beginning of the file name as follows: "ACRONYM_Canadian Collaboration Program EOI.pdf"
- 2. After saving, click on the "Submit Form" button at the end of the form and follow the automatic prompts. If there are no automatic prompts, check your email outbox to see if the form has sent.
