 - **THE NEEDS**: Energy, Biodiversity, Water Supply and Management requires climate service to cope with climate challenges
 - **PURPOSE**: Evaluate how much Copernicus Forecasts and AI algorithms may contribute to reduce uncertainty of water availability for multiple users due to natural inflows variability







- Esko Juuso University of Oulu Senior Research Fellow, Adjunct professor; Presenting: Intelligent analyzers in developing cyber physical systems for water systems
 - The idea combines data analytics, modelling and simulation to develop intelligent analyzers for advanced control, diagnostics, and optimization.
 - New autonomous modules are introduced within an intelligent framework.
 - Improved feasibility of measurements to control adaptation and situation awareness in industrial water circulation and water/wastewater treatment. Different partners find their focus in the overall system.
