




#### **Bilateral merchandise trade**








#### **Environmental goods trade by type (EUR 1000)**


#### **Evolution of the number and value (Mio EUR) of importing and exporting SMEs**


#### **Employment content of EU exports to Canada**


#### **CETA** preference utilisation rates

# **Key messages**

- Merchandise trade under CETA outperformed extra-EU trade.
- Environmental goods trade with Canada is expanding with "energy efficient machinery" augmenting the most followed by "measuring equipment for pollution levels".
- ➤ The number of EU exporting MSMEs increased by 44% and the number of importing MSMEs by 21%.
- ➤ The value of the products exported and imported by MSMEs augmented by 54% and by 58% respectively.
- ➤ The number of jobs supported by EU exports to Canada rose by 11% from 624 to 694 thousand.
