We limit access to your personal data to those employees, contractors or other third parties directly involved or associated in the organisation of this webinar. We have put in place a data breach reporting policy to deal with any suspected personal data breach and will notify any participant of a breach where we would be legally required to do so.

You have the right to access your personal data and to request your personal data to be rectified, if thedata is inaccurate or incomplete; where applicable, you have the right to request restriction or to object to processing, to request a copy or erasure of your personal data held by the data controller. If processing is based on your consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of the processing based on your consent before its withdrawal.

Your request to exercise one of the above rights will be dealt with without undue delay and within **one** month.
